# Director's Introduction

I am pleased to present the 2011/12 annual report from the Centre for Research in Nursing and Midwifery Education (CRNME).

# Achievements & Performance

In 2010, a strategic decision was taken by the Director, endorsed by the Advisory Board, to invest money from the endowments into two research studies, the AaRK and RESPONSE projects. 2011/12 has seen the successful implementation of this decision.

The Centre continues to be successful in its teaching and research activities and to consolidate its international reputation with successful PhD and MSc theses completed under the team's supervision (http://www2.surrey.ac.uk/fhms/research/centres/crnme/). Currently the CRNME team supervise twelve PhDs and throughout the year have achieved fourteen publications in high impact journals. We continue to attract overseas visitors who wish to study and work with the Centre team and this year we have hosted five international visitors and attended five international conferences.

The Centre continues to bid for research awards and has won internal and external awards this year. We plan to use the existing AaRK and RESPONSE projects' findings to develop and submit further research bids to the National Institute for Health Research (NIHR).

Helen Allan successfully applied for a Professorship in Clinical Nursing Practice with an honorary contract and one day per week working at the Royal Surrey County Hospital NHS Foundation Trust (RSCH). This clinical academic role pushes forward the Centre's national and international role in leading research in nursing and midwifery education research. Her role is to link research into practice and develop research from practice.

Carin Magnusson successfully completed her PhD titled: 'Systems of Accountability in Healthcare: The Case of Healthcare Associated Infections'. Her PhD was carried out in the NIHR Centre for Patient Safety and Service Quality/ School of Medicine at King's College London, supported by supervisors Professor Naomi Fulop and Professor Charlotte Humphrey. The research was an in-depth case study of systems of accountability for the control of healthcare associated infections within one NHS Acute Hospital Trust in England. At her Viva, which was passed without corrections, the examiners praised the theses as 'an outstanding piece of research'. Carin is hoping to build on the local and international academic and practice links made at King's.



#### Women's Health

This area of research is now being developed across Europe through the Academy of European Nursing Scientists and being led by Helen Allan. A travel award was won by Helen to write and submit with six European partners an FP7 bid. The title is 'The meaning of parenthood for infertile couples: a cross European study'.

#### Midwifery

Rosemary Towse retired from the teaching team and a new Tutor was appointed: Amy Stubbs. Amy is currently completing the PGCE in Learning & Teaching. We had a successful validation event of the Preregistration Programmes with the Nursing & Midwifery Council (NMC) and the Continuing Professional Development (CPD) & post registration programmes (which include midwifery modules and a midwifery pathway) were also successful.

Locally the maternity services are very busy with the rise in the birthrate and staffing difficulties and we are working to facilitate the students experience in placement via the placement liaison tutor role for midwifery.

Helen Allan is supervising three midwifery PhDs to add to the CRNME portfolio. Interviews are to be held for the Reader in Midwifery post during Summer 2012. The post holder will work closely with Helen to build our midwifery and women's health research profile.

# **Professor Rosemary Pope Memorial Fund Award 2012**

The Aark project is a collaboration between the CRNME, the University of Salford, and the Institute of Education. This research project aims to explore how newly qualified nurses use the knowledge learnt in university to allow them to organise, delegate and supervise care on the wards when working with and supervising healthcare assistants. The project is progressing according to schedule. NHS ethics approval was sought and approved in July 2011 and R&D was obtained for Site A and C by November 2011 and for Site B by February 2012. So far the following data has been collected across the three sites:

- 54 Observations of newly qualified nurses in practice
- 25 Interviews with newly qualified nurses
- 10 interviews with Healthcare Assistants/Support workers
- 10 interviews with Ward Managers/Matron.

We aim to complete data collection for the first phase by the end of July 2012. The research team is currently analysing these data and met for a data analysis workshop on the 13<sup>th</sup> June.

#### **Developing Erasmus Student Exchange**

As the School's Erasmus Coordinator, Khim Horton has been working closely with the International Office and other nursing contacts to develop placements for the new Undergraduate Nursing Programme which for the first time will have an Erasmus Practice module. The two institutions that will be engaged are the University of Stavanger, Norway and the University College of Dublin (UCD), Ireland.

#### Visit by colleagues from University of Stavanger

Tove Teigen and Venche Hvidsten of the University of Stavanger, Norway visited the School of Health & Social Care during 20-22 February 2012 to explore mutual opportunities for student exchanges under the Erasmus Student Exchange scheme. During their visit, they presented to academics and our Practice colleagues about their nursing programmes. They also visited local hospitals. A returned visit by Khim Horton and Cathy Derham (a tutor, Director of Studies of the newly validated Undergraduate Programme) to the University of Stavanger took place during 8-11 May. They were also showed the state of the art Stavanger Acute Medicine Foundation for Education and Research (SAFER) centre which is a partnership between the Stavanger University Hospital and Stavanger Hospital Trust, the University of Stavanger and Laerdal. Their aim is to offer training and competence development for their partners. Visits were also made to the University where Khim and Cathy presented their Nursing Curriculum and the Research programme within the School. The outcome of this visit is that Surrey will begin to accept incoming student nurses as of September 2013 while Surrey students will begin their exchange to Stavanger in 2014.

An exploratory visit to University College Dublin (UCD), Ireland by Khim Horton and Cathy Derham is planned for 23-25 July 2012 with the same aim of setting up Erasmus student exchange.

# International Centre for Nursing Ethics (ICNE)

ICNE is currently collaborating with Hecattepe University, Turkey, to organise the 2012 nursing ethics conference 'Ethical responses to challenges in care'. To date we have had over 200 abstracts submitted from 34 countries. The conference takes place from 4<sup>th</sup> to 6<sup>th</sup> October. Ann is working with University of São Paulo (USP) researchers and researchers in Germany and Ireland on a qualitative study relating to nurses' involvement in end of life decision-making.

In 2011/2012 Ann Gallagher delivered keynote lectures on the theme of dignity in care at the University of Leuven and the University of Oslo. She also examined PhD theses at the University of Sao Paulo (Autonomy and Nurses' Decision-making in ITU) and the University of Dundee (Healthcare decision-making and existentialist ethics).

#### National Yang-Ming University, June 2011 – September 2011



The CRNME hosted visits by two PhD students, Mrs Hsueh-Kuei Lin and Mrs Hai-Chiao Chen from the National Yang-Ming University 3 months in June 2011. Both students were supervised by Professor helen Allan and their topics of work include the technology of Osteoporosis Screening in Taiwan.

Ann Gallagher is working with Khim Horton and colleagues in the School of Health and Social Care to organise a two week research programme with participation from 30 colleagues from the Schools of Nursing at the University of Sao Paulo (USP), Brazil. The visit runs from 2<sup>nd</sup> to 13<sup>th</sup> July. There will be a wide range of research presentations from USP and University of Surrey researchers, inter-disciplinary workshops on human dignity and child health and keynote lectures from Guildford MP Anne Milton.



#### Professor Helen Cowie – UK Observatory for the Promotion of Non-Violence

Helen Cowie continues to carry out research into cyber bullying through the EU COST initiative examining the coping strategies that young people and their teachers use for dealing with this relatively new phenomenon.




