Key points from Named Person reports: NVS reported on PPL 7099312 (histology report update, follow-up incident from October 2023): The histology findings indicated that there was a urethral obstruction partly formed by neoplastic cells and lesions in the urinary bladder, probably due to accidental injection into the urethra instead of the prostate. No macroscopic or microscopic lesions were found in the prostate, supporting that hypothesis. Scientists have decided to stop using this model. NACWO reported overgrooming between litter mates in one of the breeding lines. The researcher decided to implement a refinement and try exposing affected animals to an 'enriched' environment setting for 15 mins a day to see if that helped reduce the problem. Findings were positive with skin sores on one animal disappearing completely. They
