

Exceptions to *A1. Regulations for taught programmes* for the Bachelor of Medicine, Bachelor of Surgery (BMBS) Graduate Medicine programme

Academic year 2025/26

Approved by Senate on 25 June 2024

Introduction and scope

1. This document sets out the exceptions to the [A1. Regulations for taught programmes](#) for the BMBS Graduate Medicine programme only and should be read in conjunction with the [A1. Regulations for taught programmes](#).
2. In the interests of completeness and transparency, a full list of regulatory exceptions to academic and student regulations which were granted by Senate in 2023 and 2024 is attached in Appendix 1 of this document. This appendix includes exceptions to [A1 Regulations for taught programmes](#), [B1 Regulations for Extenuating Circumstances](#), [B6 Regulations for fitness to practise](#) and [Code of practice for assessment and feedback](#).

Pass Mark

3. The BMBS Graduate Medicine programme prescribes a pass mark for assessing student work that relates to achieving the agreed passing standard of the module for the BMBS programme. Detail on the specific requirements to pass a module and to progress to the next academic year are outlined in the School of Medicine Programme Examination and Assessment Regulations (PEAR).

Award and credit requirements

4. The Bachelor of Medicine, Bachelor of Surgery is a Pass/Fail award and does not make use of the generic University of Surrey degree classification algorithm.
5. The number of credits per academic year required to meet the BMBS degree award exceeds the standard University minimum/maximum. Please see below an excerpt from Table 1: University awards and credits, [A1. Regulations for taught programmes](#):

Requirements for progression to the next level of study

6. To progress from one level of study of the BMBS programme to the next, a student must achieve the required credit for that level and pass all units of assessment. All modules on the BMBS programme are year-long and designated as Core.
7. Students on the BMBS programme are not permitted to progress to the next level of study with trailing credits. This is in accordance with a programmatic assessment model and to align with the Exeter Medical School requirements.

ASSESSMENT AND REASSESSMENT

Submission of coursework

8. Where a student has not submitted a coursework unit of assessment by the deadline specified, and there are no confirmed extenuating circumstances, the late submission penalty will be applied as defined in PEAR. In cases where the BMBS programme coursework assignments are Pass/Fail only or not graded, the percentage point deduction penalty is not applicable. Students on this programme should refer to the PEAR with regards to the current rules for assignments and late submission penalty.

Failure and reassessment

9. Students on the BMBS programme are not eligible to take reassessment or repeat modules without attendance. This is in accordance with the programmatic assessment model and full attendance is required to achieve the integrated learning outcomes and in medical knowledge, clinical practice, professional development and special study units to ensure the GMC standards for safe clinical practice and proficiency.
10. Where a student has failed a module(s) at the second attempt (reassessment), they are not permitted to repeat the failed unit of assessment on the third occasion. To align with the Exeter Medical School and the GMC guidance, students are only entitled to one reassessment attempt.

Timing of reassessments

11. Students on the BMBS programme are assessed throughout the academic year and there are no fixed assessment periods. Similarly, this flexibility applies to the timing of reassessments. Reassessments for units of assessment failed during the academic year will occur outside of the University of Surrey Late Summer Assessment (LSA) period.

The GMC do not set a credit requirement for medical programmes but have guidance regarding minimum teaching hours.
