User Forum Chair: Chair reported a number of items will be discussed at next User Forum meeting. Tissue sharing plans are being progressed aa well as updates to pre-start documents following publication of ARRIVE Study plans.

4. PPL 00000000 Amendment

Amendment relates to making the current establishment the primary establishment on the PPL. PPL holder has moved and taken up an academic position here. The PPL was initially reviewed by NVS, NACWO and NIO, and small changes made to the Licence to improve clarity. The PPL holder presented to the committee and described how the Licence supported their program of research. Committee members asked for more information on: i) the likelihood of trialling the drugs in humans (the PPL holder stated that human clinical trials were in planning and would likely occur within 5yrs), ii) the provision of training for individuals working on the Licence (the PPL holder would train individuals. The expected failure rate of the surgical step is low (1%) and the PPL holder is experienced in the technique); iii) the impact of using sutures versus glue to ensure eye closure during the behaviour test (this had been discussed with the NVS and glue was deemed as the most appropriate intervention. The PPL had been revised to indicate this, with suture only being considered if the glue failed); iv) cumulative severity as it was not fully reflected in the animal experience section. This section



will be revised. It was felt that 48 hours was a long time for acute pain and that local anaesthetics and painkillers, analgesics should be used; v) threshold for culling if animal showed signs of suffering and vi) how the approach taken to induce nerve damage corresponds to human conditions. The committee requested the above points to be addressed in the Licence. Subject to this being completed, the members voted to provide a favourable ethical opinion on the amendment.

5. 3Rs and Culture of Care item

i. OBSERVE guidelines

Two researchers provided a critique of the OBSERVE guidelines as they relate to orthotopic tumour models. Researchers found the OBSERVE guidelines useful for providing examples of clinical signs and for detailing the best approach for measuring the size of tumours using callipers. The researchers compared their PPL clinical score sheets to the guidelines and found that all relevant markers were listed. It was noted that the researchers had an additional marker (e.g. coat condition) that they felt was also relevant.

ii. Use of Artificial intelligence (AI) to generate clinical scoring

NIO presented the AI paper, which trialled the use of three large language models to generate clinical score sheets for inflammatory bowel disease. The author provided the same criteria and instructions to each model and assessed the outputs using a scoring system. The models completed the task with varying degrees of success. The author concluded that while useful as a starting point, the AI generated score sheets needed veterinary/welfare input to ensure they were fit for purpose.

iii. 3Rs strategy planning

A lack of time prevented extensive discussion of this item.
Chair noted that some champions were no longer available
and additional individuals are needed, especially for
replacement. Chair encouraged the team to take
ownership of the strategy document and try to progress
some items.
